AN ORDINANCE OF THE CITY OF MONONGAHELA, COUNTY OF WASHINGTON, PENNSYLVANIA, AMENDING CHAPTER 15 TO ESTABLISH AND INCLUDE PART 12 – RESTRICTED PERMIT PARKING TO READ AS FOLLOWS:

§1201 – PERMIT PARKING: Permit Parking zone is established upon and along certain streets in the City of Monongahela as follow:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Railroad Street	North	First Street to Bollman Alley

§1202 – DAYS AND HOURS PARKING PERMITS ARE IN EFFECT.

Monday through Friday from 6:00 A.M. until 6:00 P.M

§1203 – APPLICATION FOR PARKING PERMIT.

All those wishing to obtain a parking permit for the designated area must complete a parking permit application. Such application shall state the name, address, phone number, and license plate numbers for any vehicle in which the permit can be used in. Applicants must show proof of a driver’s license and proof of registration for each vehicle in which the permit could be used.

Applicants shall promptly notify the City in writing of any changes in authorized vehicles or license numbers thereof. Failure to do so may subject any vehicles not registered with the City to a parking violations or revocation of parking privileges

§1204 – DURATION OF PERMIT.

Permits are valid for one month. The permit can be extended as long as the monthly permit fee is paid on or before the last day of the month in which the permit would expire.

§1205 – DISPLAY OF PERMITS.

Permits shall be displayed in a manner determined by the Chief of Police. Failure to display parking permit may result in issuance of a parking violation

§1206 – PERMIT FEE.

The fee for permit parking placard is \$25.00 per month. The Parking Permit fee shall be set from time to time by resolution of the City Council.

§1207 – TICKETING OF VEHICLES

It shall be the duty of the police officers and parking enforcement personnel of the City of Monongahela, acting in accordance with directions of the Chief of police to ticket any vehicle which is parked in the designated Permit Parking area that does not have a valid parking permit and at the discretion of the Chief of Police the vehicle could be removed by a private towing company and the owner of the vehicle will be responsible directly to the towing company for the cost of towing and storage of the vehicle

§1208 – PENALTY PROVISION

- A. It is unlawful for any person to falsely represent himself as eligible for a parking permit or to furnish false information in an application or parking permit.
- B. It is unlawful for any person to use or display or permit the use or display of a parking permit on a motor vehicle other than that for which the permit is issued.
- C. It is unlawful for any person to copy, produce or otherwise bring into existence a facsimile or counterfeit parking permit or permits without written authorization from the City of Monongahela.

§1209 – REVOCATION OF PERMIT

The City of Monongahela may revoke the parking permit of any person found to be in violation of this division and, upon written request, the person shall surrender such permit to the City. It is unlawful to fail or refuse to surrender a revoked parking permit.

§1210 – DAMAGES OR THEFT


The City of Monongahela shall not be liable for loss or damage due to fire, theft or otherwise, to the vehicle or its contents.

REPEALER. All Ordinances or parts of Ordinances, which are inconsistent herewith, are hereby repealed.

SEVERABILITY. If any sentence, clause, Section or Part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, Sections or Parts of this Ordinance. It is hereby declared as the intent of the City Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause Section or Part thereof not been included herein.


EFFECTIVE DATE. This Ordinance shall become effective in accordance with law.
