**AN ORDINANCE OF THE CITY OF MONONGAHELA, COUNTY OF WASHINGTON, PENNSYLVANIA, IMPOSING A SURCHARGE UPON ALL PROPERTY OWNERS IN THE CITY OF MONONGAHELA WHO ARE USERS OF SEWAGE FACILITIES AND REQUIRING THE MUNICIPAL AUTHORITY OF THE CITY OF MONONGAHELA TO BILL, COLLECT AND REMIT THE SAME.**

The Council of the City of Monongahela, County of Washington, hereby enacts and ordains as follows:

**SECTION 1.** Upon Motion of Councilman Kulak, seconded by Mayor Kepics, it is **RESOLVED** that the City of Monongahela intends to impose a surcharge of Eight and 00/100 Dollars (\$8.00) per month by Ordinance upon all commercial and residential users of sewage facilities within the boundaries of the City of Monongahela which shall be a monthly surcharge added to the bill monthly submitted to such parties by the Municipal Authority of the City of Monongahela for the purpose of discharging the indebtedness to be incurred by the City of Monongahela with the Pennsylvania Infrastructure Investment Authority ("PennVest") for construction of sanitary sewer lines and a pump station on Nelson Street.

**SECTION 2.** The Municipal Authority of the City of Monongahela shall be required to bill the sum of Eight and 00/100 Dollars (\$8.00) per month for and on behalf of the City of Monongahela on every sewer tap, whether the same be residential or commercial use.

**SECTION 3.** Where a property owner has multiple tenancies without separate meters, the property owner shall be billed Eight and 00/100 Dollars (\$8.00) for each tenant.

**SECTION 4.** The Municipal Authority of the City of Monongahela shall be required to collect and remit such surcharge monthly to the City of Monongahela, together with a written report of payment.

**SECTION 5.** The Municipal Authority of the City of Monongahela is authorized, directed and empowered to enforce the collection of such surcharge in the same manner and fashion that is permitted by law to collect payment of all sewer billings.

**SECTION 6.** The beginning date of imposition of surcharge and collection shall be the 1<sup>st</sup> day of January, 2016.

**SEVERABILITY.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intend of the City Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof had not been included herein.


**EFFECTIVE DATE.** This Ordinance shall become effective in accordance with law.
